Minutes of the Hybrid Council Meeting on Wednesday 17th April 2024 at 7.00pm

143. Apologies: Cllrs S. Jones, A. Jones.

Cllr Pigott invited Mrs C. Dunbar-Pollard to address the Council

Mr Dundar-Pollard spoke about the open meeting and the Pylons/Turbines that were being planned by Bute/Green Gen., the Town Council position on the same and a way forward. A group had now been set up and would be fighting the proposals.

Cllr Pigott thanked Mrs Dunbar-Pollard for her comments and feedback they had received from several residents.

146. Councillor Updates

Dolwen Fields – Cllr M. Pigott – July 13th – plan for a 2k and 5k run with Community Groups and a table top sale. Also the Dolwen Fields Committee are looking for more volunteers to help.

- Cllr G. Watkins Proposal for having a wildlife pond behind the Pavilion, Concern over Health & Safety drowning. May need a fence around it Cllr Watkins to bring back to the table. On site meeting with Cllr Davies, Price. Also H&S on site meeting Cllr Pigott and Rickard.
- PlayPark Group no recent update. Window on Shelter has been broken. Cost for repair to be looked at. **Action:** Clerk to contact handyman for costs.
- Dogs on Field reports of dogs being taken onto field by residents as well as visitors. Signs on gates
 are too small and not serving as a deterrent. New signs proposed by Cllr Davies and seconded by Cllr
 Pace-Avery. Action: Clerk to order bigger signs for both entrance gates.

Victoria Hall – Solicitor has been on sick leave, now back at work but having to work through backlog of work

Smart WiFi – Third hub in place, Still waiting on Powys Council to provide dates for training.

Action: Clerk to chase.

Twinning -No meeting held.

Festival Committee – 3 members met last week. Looking at who would provide the lights if the Festival Committee didn't. Due to costs for erecting and taking down of lighting plus a licence, will look at doing lights on Town Square and work with Heritage Committee to provide display at front of building. Cllr Price meeting with Blanchard illuminations to see what can be achieved. Existing lights in the old bus shelter to be looked at. Maybe look at funding for lights on the bridge.

147. Update on Powys Matters affecting Llanwrtyd Wells - County Councillor P. James

- There will be a Health and Wellbeing Fair on the 13th May with PAVO venue to be advised.
- Hedging issues has been completed.
- Manhole cover on Llandovery Road has been repaired.
- Environmental issue in Victoria Wells has been reported to Environmental Health to deal with.

- New laws concerning trade waste came into force on the 6th April. All trade waste recycling has to be sorted into relevant bins.
- 148. Planning Applications and Decisions No new Planning Applications or Decisions received.

 Chalets on Station Road Proposed Development Councillors had reviewed the correspondence received concerning the development. Under the current planning guidelines the Town Councils decision, having taken into consideration the comments and strength of feeling of residents, was not to change its support of the application, being a tourist destination. With regard to the Environmental impact, this was already being dealt with by the Environment Agency, who are best placed to make the expert recommendations required along with the Highway Agency and Powys Planning. Proposed by Cllr Davies and Seconded by Cllr Pace-Avery.
- **149. Planning Application Training and Guidance** Planning Application training had been requested by Cllr S. Jones. Clerk produced Guidelines and further training providers was to be sought from Planning Aid Wales. **Action:** Clerk to source and report back for next meeting.
- **150. Open Meeting on Pylons -** Following the meeting and emails and letters sent to the Town Council, it was agreed to hold a separate meeting to tonight's meeting, to discuss further. Date to be arranged.
